**TO: ALL PARENTS OR CUSTODIANS AND CHILDREN RECEIVING A SUMMONS TO APPEAR IN JUVENILE COURT**

**PLEASE READ ALL OF THE ENCLOSED PAPERS CAREFULLY AND FOLLOW THE INSTRUCTIONS**

1. Enclosed is a copy of a complaint filed in Juvenile Court and the Summons stating the date you are required to appear.
2. **The juvenile and both parents are required to appear for hearing** (if divorced, only the custodial parent need appear with the juvenile).
3. To **ADMIT** to the charge(s): please appear at the scheduled time as it appears on the summons.  
Please bring with you:
  - 1) The Juvenile's social security number
  - 2) The Juvenile's health insurance card or medical card
  - 3) The enclosed youth rights sheet
4. To **DENY** the charge(s): please complete these two steps:
  - 1.) Call the Juvenile Court at (740) 833-2600 or (740) 548-7313, (ext. 2600) and tell the operator you want to enter a denial,  

AND
  - 2.) You must **complete** and **sign** all of the attached forms and mail them to the Delaware County Juvenile Court, 88 N. Sandusky Street, Delaware, Ohio 43015
5. **Directions and parking information are on the back of this page.**

## Directions to Juvenile Court (located directly across from County Courthouse)

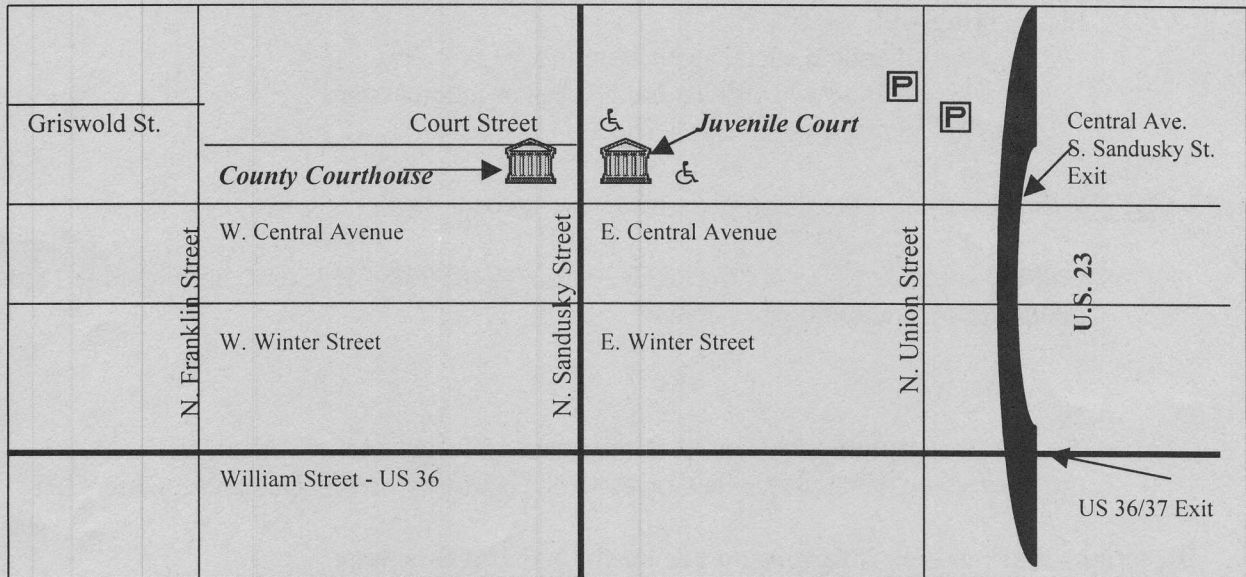
**From the east:** (Sunbury) S.R. 36/37 West to Delaware. On entering Delaware, you will come to a railroad overpass, yield to the right (S.R. 37) to Sandusky Street. Turn right, Court located immediately on the right hand side.

**From the west:** (Ostrander, Marysville) S.R. 37 to Downtown Delaware. Turn left on Sandusky Street. Court located immediately on right side.  
S.R. 36 E to downtown Delaware. Turn left on Sandusky Street, go to 2nd traffic light. Court on right.

**From Columbus:** 23 N to Sandusky/William Street exit. (Second Delaware exit) Turn left on William Street. 3rd traffic light turn right onto Sandusky Street. Go past 2<sup>nd</sup> traffic light; Court located on right.

71 N to Delaware exit. Turn left (S.R. 36/37). Go approximately 10 miles to railroad overpass; bear to the right at overpass (S.R. 37). Proceed to Sandusky Street. Turn right - court located immediately on right.

**From North:** (Marion) 23 S to Central Ave. and S. Sandusky Street exit. Turn right. At 2nd light turn right (Sandusky Street) Court immediately on right side.



### Parking/Access



Handicapped parking is available on North Sandusky Street and East Central Avenue. (directly in front of our entrance doors.)



There is parking located on Sandusky Street, North Union Street, North Franklin Street and West Central Avenue or behind the County Courthouse. Some parking is metered.
